

GENERAL INFORMATION:

Saf-T-Side™ 800 EL is a spray oil emulsion miticide/ insecticide for the control of Spidermites and Whiteflies on Roses and Tomatoes; Aphids and Whiteflies on French beans.

Mode of action: Saf-T-Side™ 800 EL acts primarily through the suffocation of eggs, larvae, nymphs and adults of insects and mites.

Preparation of spray mixture: Half fill the spray tank with water. Add the required amount of Saf-T-Side™ 800 EL and mix while stirring or agitating. Fill the water to the required level and continue with stirring or agitation until the mixture is thoroughly uniform. Ensure that the mixture is used the same day.

Re-entry interval: Once the spray dries.

Pre-harvest interval: 1 day

HAZARDS / PRECAUTIONS:

Handling: Wear protective clothing: overalls, impermeable boots, gloves and face shield when handling the product. Do not eat, drink or smoke while using it. Avoid contact with skin, eyes and clothing.

After work: Remove protective clothing and wash hands thoroughly with soap and plenty of water. Wash protective clothing before reusing them.

STORAGE:

Store in tightly closed original container in a cool dry well ventilated place, under lock and key so that children and unauthorized persons do not have access. Keep away from food, drinks and animal feeds.

DISPOSAL: Dispose of by triple-rinsing, crushing and perforating empty containers. Dispose of in a safe place away from water supplies in accordance with national legislation and regulations. Do not re-use empty containers for any other purpose.

PESTICIDE LEAKAGE AND SPILLAGE: Contaminated absorbent material must be stored in marked waste bins prior to disposal in an authorized land-fill site in accordance with national legislation and regulations.

ENVIRONMENTAL HAZARDS: Do not contaminate ponds and waterways by direct application, cleaning of equipment, disposal of waste and empty containers.
