Rate Recommendations

Foliar Application

Non-Irrigated Crops: Apply 1-3 litres in a minimum of 100 litres of water per ha and repeat as needed.

 $\mbox{\it Irrigated Crops:}$ Apply 2-4 litres in a minimum of 100 litres of water per ha and repeat as needed.

Aerial: Apply 1-3 litres in a minimum of 20 litres of water per ha and repeat as needed.

Soil Application

Use 2.4 litres in a minimum of 100 litres of water per ha. Not for use with starter fertilizer.

Mixing and Handling Instructions

Put 1/3 to 2/3 of total required water volume in tank. Add adjuvants, fertilizers, and pesticides if desired and agitate until thoroughly mixed. Add recommended amount of this product and agitate until thoroughly mixed. Fill tank with remainder of desired water.

Caution: Check chemical mixture compatibility using a jar test prior to application, especially for high phosphate and alkaline (high pH) solutions.
